us. Managers from across the state, vendors and individuals have generously given funds toward this effort. Our commitments were met with \$30,000 dollars in scholarships that will be awarded to the 2020 scholarships winners, \$10,000 to our TEC Government-In-Action Youth Tour program by sponsoring over two of T-shirts provided for the 100 plus students and chaperones and a generous donation to Rural Friend/ACRE in their efforts to oversee the governmental direction for our cooperatives. TREWA received over \$100,000 through these generous donations.

We are now moving forward with plans for 2021 by encouraging each of you to renew your membership or join TREWA if you have not had the chance. 

Safety & Efficiency

Save Energy with LEDs

LED lights last up to 30 times longer than incandescents, reducing the need to replace bulbs in high or hard-to-reach places. Below are LED lighting suggestions for your home.











Living Room Lamps

Table or floor three-way lamps using LED bulbs provide 620, 1,600 or 2,150 lumens of soft white light and deliver up to 25,000 hours of light.

Kitchen

Dimmable recessed LED conversion lights add a warm glow of up to 1,200 lumens for kitchen workspaces and add far less heat to your kitchen. Each bulb could last 10 years.

Bedrooms and Hallways

Long-life LEDs are ideal for ceiling fixtures. A 9-watt LED produces the same 800 lumens of light as a 60-watt incandescent, and uses about 80 percent less energy.

Bathrooms

Omnidirectional LED globe bulbs are designed to provide a warm glow ideal for bathrooms. A 6-watt bulb produces 450 lumens and lasts up to 15,000 hours.

Outdoors

A 6-watt, 500 lumen LED bulb can replace a 40-watt incandescent bulb. Designed to last up to 30,000 hours, it could be a one-time switch.

Tips For **Energy Efficiency**

Cooler temps are just around the corner! Is your home's heating system ready? Remember to replace furnace filters once a month or as recommended. Remember to clean vents and ducts regularly to increase efficiency.

EASY WAYS TO SAVE ENERGY

WEATHERIZE

Seal doors and windows with caulk, weather stripping and/or plastic film.



SEAL IN WARMTH

Close blinds and curtains during the night to keep cold air out. Open them during the day to let sunlight in.



COOK UP SAVINGS

Use smaller appliances, like microwaves, toaster ovens and slow cookers when possible.



HOLIDAY LIGHTING COMPARISON

Holiday lighting options have come a long way over the last few decades. The chart below shows three types of lighting options, including wattage and operating cost comparisons.


TYPE OF LAMP	WATTAGE PER LAMP	WATTAGE PER 50 LAMPS	SEASONAL OPERATING COST*
C9 INCANDESCENT	7	350	\$13.33
MINI INCANDESCENT	.425	21.25	\$0.81
LED J	.069	3.45	\$0.13

*Using 40 days of operation, 8 hours per day, \$.119 per kWh (DOE average) In addition, the LED will last as much as 40 times longer than the incandescent lamps.



Rural friends/ACRE supports legislators who have not only demonstrated an understanding of the unique role electric cooperatives have played in the development of rural communities, but who have also been recognized for their communities to represent the rural interests of electric cooperatives and their members.

Rural Friends/ACRE was formed with the mission of making the voice of electric co-op consumers heard in the Texas Legislature and U.S. Congress. Rural Friends of Electric Cooperatives is the nonpartisan political action committee that supports candidates seeking election to the Texas Legislature. It operates under a set of bylaws and the policies of a board of directors composed of electric co-op leaders elected from around the state. ACRE - the Action Committee for Rural Electrification - supports candidates for the U.S. Congress. Rural Friends and ACRE are subject to all state and federal campaign finance laws and reporting requirements.

Membership is strictly voluntary and consists of persons who have an interest in preserving and defending our local electric co-ops. Rural Friends/ACRE raises personal, voluntary contributions from supporters who care about our co-ops and the communities we serve.

Contributions go to candidates for state and federal office who have demonstrated support for electric co-op goals, who share co-op values and who want electric co-ops to be successful. Support is based on voting records on legislation affecting electric co-ops, statements on co-op issues, and historical stances on those issues.
